Summary of Michael Geller's talk on Monday 16th October, 2023

Michael Geller gave an outstanding talk on Monday 16th October by outlining the many options for people who want to downsize their homes and the challenges that face developers, municipalities, owners and renters in this housing market.

Initially he focused on the new kinds of neighbourhoods which would suit older residents – smaller, community centred spaces which are more walkable. He showed several examples of single family homes which are being built with smaller "footprints" than conventional single family homes. He also talked about parking allowances required by municipalities which fly in the face of the fact that older seniors often downsize in terms of their numbers of vehicles.

Michael mentioned that duplexes can be side by side, or semi-detached two storey, and townhouses, and "stacked" townhouses. He also talked about the increasing numbers of laneway or coach house units that are being developed which can allow for multi-generational living, but he cautioned that owners thinking of developing such units should be aware of any tax implications.

Condominiums or purpose built rentals are also an option when considering downsizing and because rentals include many of the costs of owning a home (insurance of the structure, heat, water, waste disposal, etc.), the costs are not out of line. On the subject of wood construction he noted that this was becoming an important element of construction, and interestingly wood structures are now remarkably fire resistant contrary to popular belief.

One concern expressed in the current market place is purchasing dwellings on leased land and Michael indicated that the Lower Mainland had a number of such properties with 99 year leases that should not cause concern in terms of purchasing. Leased land allows for the development of less expensive housing than developments which include the cost of the land.

Michael's presentation was filled with very useful illustrations of potential housing options, and was also sprinkled with some hilarious photos.



Canada Fisheries and Oceans Pacific Science Enterprise Centre Tour 25 September

It was a blustery fall day, still 31 Probus Club ladies turned up for the Fisheries Research Centre tour decked out in rain gear. In two separate groups, we were guided through a maze of outdoor and indoor fish tanks and inside laboratories where experiments and research take place. Our guides highlighted the wide range of research projects undertaken by collaboration between government, academic, private sector, societies and indigenous groups.

In the 1950's the West Vancouver waterfront site housed a large fish cannery owned by the Millard family. They closed the cannery and donated the property to the Federal Government, as a way to payback their success. The land was to be used in perpetuity for research in to aquatic species. Up until 2016, the West Vancouver research facility was not open to the public, leaving a lot of wild speculation by residents as to what was going on there. Since then, the facility has opened up to tours of school children, and groups such as ours.

The West Vancouver location is ideal with access to salt water from Burrard inlet, creek water from Capilano River and several fresh water wells on site. This unique water access allows for

recreating optimum environments for researching sea and fresh water species. Hundreds of indoor and outdoor fish tanks with miles of pipes and controls are set up to house the aquatic animals for the various projects.

Examples of some of the research projects underway discussed were:

- Genetics and fish breeding the research focuses on the scientific issues coming out of the private sector aquaculture practices by recreating and studying the hybrid animals and environment in order to advise the Federal Government for consideration in licensing and regulation. One project observed on the tour was the creation of a hybrid Coho/Trout species, which we saw in the tanks.
- Aqua culture fish feed current fish feed is derived from sea species so research is underway to develop a non-fish feed for the fish.
- Plastics and the effect on the oceans research into the implications of plastic garbage and microfibers from cloths washing effluent on aquatic life
- Bi-valve (clam, oysters, mussels, scallops) aquaculture and environmental effect on surrounding waters studies are being done on specific bays where culturing is done measuring the effects and concentration of effluent on the waters. The goal is to find the optimum number of licenses that could safely be issued in a specific bay.





There is so much going on at this centre it is impossible to capture it in one article. We are exploring having one of the research groups come speak to our Club next year. Afterwards 10 members met for lunch and warmed by the fire at the Red Lion Pub in Dundarave. Thanks to Inga Harding for organizing this popular event.
